**Section 125 Deductions Include – Health Insurance Premium, Cancer/Accident, Medical Reimbursement, and Childcare**

**Schedule for deductions are as follows:**

- Section 125 Health Insurance Prem., Cancer/Accident, AUL Supplemental Life - 19 Deductions (Beginning 9/12/08–Ending 6/5/09, but no deduction will be taken on 1/2/09.
- Section 125 Medical Reimbursement, Childcare – 20 Deductions (Beginning 9/12/08–Ending 6/5/09, deduction will be taken on 1/2/09.
- Credit Union, and 403(b) – 26 Deductions
- U.S. Savings Bonds – 13 Deductions (every other pay beginning 9/12/08)
- Arts United - 10 Deductions (Beginning 9/12/08 – Ending 1/16/09)
- United Way - 8 Deductions (Beginning 2/27/09 – Ending 6/5/09)
- Dues - 20 Deductions (Beginning 9/12/08 – Ending 6/5/09)
