Collegiate Connection/Dual Credit. Each EACS high school receives up to \$5,000 annually from the Foundation to provide reimbursement for successful college coursework completion by EACS juniors and seniors. To date, through this support, **728 EACS students** have benefited from our Collegiate Connection / Dual Credit program.

EACS Teacher of the Year. Beginning with SY14/15, the Foundation now provides up to \$250 for each EACS building-level Teacher of the Year for classroom supplies/materials. Annually, each building-level EACS K-12 Teacher of the Year will receive this support.
